MWCSD intends to spend the SSBA funds on the school connectivity infrastructure. Over the past two years, the District has invested in building a robust wireless infrastructure and increasing students' and teachers' access to desktops and laptops, Chromebooks, iPads, and other devices. In all schools, there are stationary and mobile computer labs, iPad carts, Chromebook carts, interactive whiteboards and other display technologies. Based on these investments and our continuing refresh cycle of computers that are five years old, the most effective way to expend the SSBA fund is in building infrastructure, through replacing old switches, running new fiber between IDFs and MDF and upgrading wireless controllers with wireless access points.
