The Aruba Wi-Fi network in North Bellmore exceeded the minimum requirements for connectivity. Every instruction space has an access point capable of up to 60 consecutive connections. In potential testing areas the WiFi can handle up to 300 connections simultaneously. Our current 1gb connection per building easily support and exceeds our demands for connectivity.

The expansion of our Smartboard initiative falls directly in line with our annual upgrades. Each year, the district replaces one grade level of Smartboards. This year we decided to use the remaining SSBA funds to do so and meet his goal. The model of Smartboard being purchased is the same and the model purchased last year for Grade 2. A simple 110v electrical is all that is required for connectivity. The SBs are not joined to our Wi-Fi network, they are connected via Cat-6 cable, via a dedicated network drop for the Smartboard.

The purchase of new Smartboards is based on our success with our current/original boards. These boards have consistently provided a method of engaging students in learning. Coupled with the use of Smart Notebook, teachers have created thousands of shard Notebook files which contribute to their success and the success of their students. Our goal was to continue on this path of success and make changes to the brand or functionality of the boards, but simply update and improve the functionality, in a platform that was familiar to our instructional staff.

The interactive boards help to support our neediest learners. For example, through the use of magnification tools, our students with visual limitations are able to access content and not necessarily be sitting directly in front of the board. Not only are those with disabilities, but the boards support all visual learners, engaging them in the content through videos, slide decks or online curriculum. We also utilize Mirroring 360 so that content on the Smartboard can be shared directly to student devices as the boards are on the same wifi network. Teachers also have the ability to translate webpages and content as required for ELL students. The tactile nature of the boards allow for interaction with students who are able to write with their fingers should they have fine motor skill disabilities, creating an inclusive environment.

While the Smartboards are an in-classroom device, they do offer a large screen, web-connected platform from which to hold whole class Zoom meetings. Many teachers use the Smartboards to "Zoom" parents in as *Mystery Readers*, or to join in class activities remotely. Teachers also conduct virtual field trips and have special guest join via Zoom/Smartboard, opening up the outside world to the students while in the comfort of their classrooms.

The purchase of Smart branded, interactive panels creates a seamless integration as we are already on the Smart branded platform. We have been installing these panels across the district year over year with great success on the part of the teachers. We install the board in the evening and we are on site to provide training the following day to those that receive boards. The platform is very familiar and similar to what teachers have already been using, so the transition is simple and welcomed. Before we leave the room we confirm that the teachers fully understand the capabilities of the new panels and our protocols for shut down, wifi and screen sharing.
