The primary device(s) in this SSIP are Promethean interactive boards and related accessories. These new boards will represent both a replacement to existing board technology in place as well as increasing the availability of these devices to all classrooms. As such the infrastructure currently in place is deemed sufficient to support the proposed devices. Additionally, the District would be purchasing a quantity of 125 Chromebooks to supplement our 1:1 initiative. Also Chromebook cases, Mac Mini computers, a MakerBot 3D printer, and charging stations would be purchased to cover instructional technology needs identified by our Technology Team.

The (3) line items labeled "install boards" were entered as such to match the vendor proposal for the installation services. The first (2) items listed at \$18,750/Ea. can be combined for a total install price of \$37,500, calculated at (75) units at \$500/Ea.. The breakdown into (2) line items is simply based on their required payment terms. The third line item listed at \$11,250, calculated at (75) units at \$150/Ea. is for extended cables and raceways per unit installed.

The additional/upgraded interactive board technology into all instructional classrooms has been an objective of the District for several years based on best practices in the educational setting. The improved interactive capabilities of the proposed new boards will help all students, especially those students with certain forms of learning disabilities, to access and interact with various curriculum. The technology requested will provide greater access to interactive learning opportunities for both in-person learners as well as remote learners. Opportunities such as streaming various alternative instructional programs and events are currently limited primarily to a single distance learning classroom located in one educational building. These additional instructional opportunities will benefit all students in varying degrees, but may be particularly beneficial should the District enroll future students with certain learning disabilities as well as English language learners. The technology should also benefit those students who struggle to succeed in the traditional classroom learning model and are often the students who develop the largest learning gaps.
