New York Mills is committed to supporting independent learning through their one to one project. This project has been in place since the pandemic and depends on a robust wireless network.

New York Mills works closely with the Oneida Herkimer Madison BOCES Technology team to insure the quality and strength of their wireless and wired network. They have a BOCES technician who is assigned to the district on a regular basis. This technician regularly meets with the administrators and lead teachers to review the instructional goals of each learning and public space, and the network capacity in those spaces.

If there are any upgrades or changes required that is implemented either through purchases via a BOCES COSERV or a Federal E-rate project.

This project proposes the purchases of two classes of devices. Chromebooks and Interactive display boards.

New York Mills has been using chromebooks for several years. The devices are reliable, require minimum support, and support students to meet their instructional goals. Using Docs, Sheets, and Slides, the students use 21st Century tools to become active, participatory learners rather than passive receivers of information.

The district is also proposing purchasing the next generation of interactive display boards for their classrooms. Using funds from a previous plan the district began this process. The boards are an integral part of the NY Mills instructional model. They can be used to display a multitude of resources including video or print. The students can present their work on them for peer review as well as student based learning. Currently many of the classrooms have interactive boards with projectors that are at or approaching end of life. This plan is an effort to support the instructional model that the teachers have adopted without interruption.

One of the first goals of the technology proposed in this application is to enhance differentiated instruction. In a traditional classroom the students have two options. Learn through the teacher's lectures or through the text book. In a classroom with interactive displays and chromebooks, the resources available to meet student learning goals expands massively. For example the interactive display boards have the capacity to introduce simulations, or dramatizations that allow the students to apply the theories that they are being presented. For example, in a primary grades classroom a teacher can use a simulation to help young students understand coins and their value. By moving coins around on the display students can compare the value of pennies, nickles and dimes to purchase goods in a simulations. Instead of rote memorization the students learn by applying the knowledge. In a high school biology class, the display can help students complete dissections multiple times. If a student doesn't understand the frog dissection, the display can repeat the process rather than depend on a single 45 minute lab period.

Class time has traditionally been limited to that 45 minute period for secondary students. Using google shares or emails, the classroom time is no longer limited. A student that might require clarification can reach out to their instructor during study halls or lunch. Additionally, a teacher could provide URL links to demonstrations or dramatizations in a shared folder for a student to review a second or third time.

Students who are English language learners face an uphill battle. Some students have limited access to a translator. With a global classroom offered via a chromebooks, the student can dialouge wth translators who aren't physically in the classroom or even on site. They can also translate text from english to their native language at the click of a button when they need it, not at an arbitrary time when the translator might be available.

Students with disabilities often need specific strategies to be successful. Extended time, alternative presentations, remedial resources can all be offered to students without the embarassment of being singled out in the classroom.

The items proposed in this application enhance the opportunities that the district offers to improve communication for the district.

New York Mills already has a student management system that offers a robust parent portal. Real time access to attendance, academics, discipline, as well as teacher email communication is provided through this system.

The classroom interactive displays as well as the chromebooks both supplement opportunities for regional partnerships or distance learning. The cameras on the chromebooks, coupled with the interactive displays make EVERY classroom a distance learning classrooms. The Bronx Zoo is now at their fingertips. Interviews with historical characters such as re-enactors can be offered any time any where. Imagine interviewing Ben Franklin, Abe Lincoln, or a civil war camp follower. I have observed second graders interviewing an engineer who worked on the Mars Rover. Science is no longer an abstract for those students.

New York Mills has long been an active participant in regional Model Schools staff development programs. Many of the classrooms equipped with Smart Boards and projectors are staffed by teachers who have completed Model Schools Smart Board trainings. These trainings are provided by fellow educators who are familiar with the appropriate curriculum and can assist in the development of focused instructional plans to assist all students to be successful. In the event that a teacher needs to improve their skill levels on the upgraded equipment, Early adopters are available for one to one consulting. The district also offers technology support via the BOCES staff who is scheduled in the building on a weekly basis.

In addition, teachers are encouraged to work collaboratively with Master level teacher integrators. Teachers can apply for and receive release time to observe fellow teachers as well as successful regional teacher integrators
