Classroom Learning Technology Equipment (Devices)

1. **Describe the devices you intend to purchase and their compatibility with existing or planned platforms or systems.**

The Educare Center currently has six 65" Promethean ActivPanel Interactive boards, which are shared among out 12 classrooms. Utilizing these grant dollars, we would purchase six additional boards, and 12 accompanying Chromeboxes which would allow for each class to have their own. The devices are mobile and height adjustable, making them a versatile option when teachers are working with students who have varying physical and intellectual disabilities. Chromebox add-ons have sizeable memory, so teachers will be able to have several tabs open at a time. This means our Special Educators will be able to toggle through multiple documents, sites, or activities which will allow them to present information in a way that suits each child's individual needs. Chromeboxes will help the Promethean boards respond very quickly to the teacher's command.

Having six of the Promethean boards already, we have seen the benefit first-hand. Teachers have reported that students respond positively to this technology and are easily engaged in lessons when presented via interactive touch panel. Adapted lessons, specialized activities, and a variety of interactive cues keep our students engaged in learning and working towards their Individualized Education Program goals. Students will gain access to state-of-the-art technology all day.
