The OESJ school has a dedicated 1 GB internet connection. The OESJ Elementary School and Jr/Sr High School are interconnected by a dedicated 1GB fiber pipe. Within each building there is a 1GB network made up of multiple fiber connected switches and routers that support all computing technology devices. Traffic analytics show at peak 863 active unique clients with a usage of 1.73 TB (1.03 TB, 1723.74 GB).

The network has shown to be resilient during CBT testing with an average of 100 wireless devices per building when testing occurs without any noticeable delays ... this in combination with clients that are in use during testing times by other students taking class instruction.

The OESJ wireless network is comprised of 55 WAP's in the Jr/Sr High School and 59 WAP's in the Elementary school that provide building and athletic field coverage. Traffic analytics shows a weekly usage average of 1.13 TB with a degree of latency of less than 14.95 ms and packet loss of less than 6 percent (Anything below 10% is considered to be acceptable)

The OESJ school district intends to purchase Chromebooks and Graphing calculators for student use, Laptops for faculty use, Desktop computers for classroom use and server technology to refresh current technologies that support the learning environment and applications. The district has a replacement cycle for the items listed in this plan and are as follows:

- Laptop – 3 Years
- Chromebook – 3 years
- Desktop – 5 years
- Servers – 5 to 7 years
- Interactive Display Panel - 10 Years
- Building Access System - 20 years
- Building Camera System – 10 years
- Building PA System – 20 years
- District Network – 7 years

The district consists of 2 buildings that have HVAC systems that were updated 3 years ago as part of capitol project and offer supplemental generator powered backup systems at both sites. Both buildings have dedicated MDF rooms with multiple IDF room locations that have sufficient power and temperature controlled environments.

Vmware or Hyper-V is an operating system that is used to manage the resources to build Virtual Computing Servers ... The virtual computing servers would be used to house and supply applications to support the learning environment. For example we use virtual servers to extract data from our Student Information System and then transfer or upload that data to learning applications such as Castle Learning, Alexandria (Library System), IReady and NoodleTools to name a few. The data is uploaded to applications such as Clever that aid in the K-3 students log into their chromebooks using a badge.
