Pearl River believes that all students are more successful when they are able to attend a school where they feel safe and secure. It takes many components to provide a safe and secure learning environment. Pearl River Central Schools is working to improve one of those components with this application.

Pearl River has an existing Video Security system. It has older, analog cameras of low resolution and limited views. Additionally, the recording component of that system has very limited capacity and almost no space to archive specific incidents. This proposal addresses those vulnerabilities. Additional cameras will be installed to address areas both internal to the buildings and on external campus locations. These cameras will be digital with the improved resolution and extended range that is essential for a school district. Additionally, digital storage servers will be purchased with greatly expanded storage capacity. All video will be stored for a minimum of 30 days. The servers will also have the capacity to archive specific events indefinitely. This will allow building administrators to keep a record of specific events for future review.

All plans and specifications for the erection, repair, enlargement or remodeling of school buildings in any public school district in the State must be reviewed and approved by the Commissioner.
