Perry Central Schools has maintained a strong infrastructure including electrical, HVAC and networking through multiple capitol projects In this amendment, the district has identified classroom devices required to support expanded opportunities via technology. The electrical and HVAC capacity for is more than adequate to support these devices. Network infrastructure far exceeds the needs of the devices proposed in this application.

The chromebooks proposed are an excellent component of the Technology Plan implementation. All students are assigned a chrome book. This includes regular program students and students with special needs.

Students with disabilities can take advantage of extended learning time that is a product of a one-to-one program. The students can start work in their classrooms and then continue seamlessly when they are later working in with an aide or at home. Additionally, the managed email capacity of the Google program allows for consultation with teachers or aides outside of the traditional 45 minute class schedule.

English Language Learners or English as a Second Language students have access to the built in translation services of Google.

Documents in print or student generated documents can be converted from English to native language and native language to English.

While the chrome books don't directly contribute to ongoing communication with parents, the Google Classroom component provides a direct email link for parents with their student's instructional team.. Additionally, the Perry District maintains a robust Parent Portal in their student management system. Parents have real time access to attendance discipline, and assignment information

Finally, the chrome books are a portable distance learning station. Each machine has a built in camera and microphone to facilitate

Google Meets with instructors or fellow students. Additionally, every classroom has distance learning with regional partnerships through their chromebook. The instructor can tap into experts in the field or facilitate a virtual field trip to support the in classroom learning.
