As such, we are maximizing both our investment as well as utilize the ability for our bandwidth to "burst" as necessary when demand peaks. The district currently contracts for 539Mbps of bandwidth and has the ability to burst above 539Mbps as needed.

The project will improve the integrity of a wiring closet in Circleville Middle School by relocating the closet from a custodial closet with a slop sink to a more secure location with a more appropriate environment for this equipment. The rest of the district's wiring closets were addressed in the district's Smart Schools Phase 1 and Phase 2 projects. This relocation will help ensure maximum up time for the district's high-speed broadband connection through out this school and provide the fiber optic backbone necessary to increase the speed between this wiring closet and this building's MDF closet. The majority of this project will focus on high tech security features.
