The display can be connected to Windows PCs or Mac computers, and it supports various collaboration platforms like Microsoft Teams, Zoom, and Google Meet.

The ModCAM Plus is a digital camera addition to the Newline Interactive Televisions that allows for clear visual demonstrations that might not be easily seen with traditional whiteboards or overhead projectors. It is especially beneficial in visual learning, where students can see detailed images and have a more interactive learning experience. It also saves time as teachers don't need to write or draw repeatedly; they can display content live for all to see. The ModCAM Plus may also be utilized for distant learning opportunities.
