High-Tech Security Features

Using Smart Schools Bond Act funding, Potsdam Central School District plans to implement an advanced video surveillance solution that will enhance safety on school campuses. The district will purchase and deploy a range of Verkada cameras—indoor and outdoor dome cameras, bullet cameras, fisheye cameras, and multisensor cameras—that collectively provide comprehensive coverage of key areas. Each camera includes substantial onboard storage and is paired with a five-year camera license for ongoing software and security updates. These modern devices capture high-definition footage and offer features such as real-time alerts, remote access, and secure cloud-based management. As a result, the district will be able to monitor school buildings and grounds more effectively, identify and respond to safety concerns, and create a more secure environment for students, staff, and the community.
