1. Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

In an emergency situation, getting the correct information to the correct individuals is critical. In this plan, Rondout Valley Central Schools is addressing this challenge.

Currently, one of the vulnerabilities is the classroom communication system. The old, analog phone system has very limited capacities, and a number of locations where the service has been compromised or has failed completely. The proposed system addresses those concerns.

First, the new system is an IP based system. The new classroom phone system is based on the district computer network instead of an isolated, stand alone system. With the old system no one was aware of problems or areas where the system might have failed until they attempted to use the devices. In an emergency, classrooms, students, or teachers might not receive the emergency communication and end up in a vulnerable or out right dangerous situation.

Secondly, the old system was a one-to-one communication system. The office could call one location and share information. In an emergency, it could be essential to contact groups of phones or all phones with a common message. The new system has that capability.

Third, In an emergency, getting the correct information to the correct people is critical. The new system allows you to pre-record messages. If there were an intruder in the building, the administration could send a message to a group of classrooms with specific information.

Finally, With the current situation, an individual might call 9-11. That message should go out to the 9-11 center and the proper authorities could respond to the building. The administration in that building might not be aware of the 9-11 emergency until the emergency responders show up. With the proposed system, a teacher, staff, or student who dials 9-11 is immediately linked to the 9-11 center. In addition, the phones in the main office will ring constantly until someone in that location responds. Additionally, they are informed that a 9-11 call has been initiated from a specific phone in a specific room location in that building. No longer will they be surprised as the Troopers or an ambulance pulls up to the curb responding to a call in the building.
