Salem would like to amend the original plan to add additional funds for interactive whiteboards to complete the original plan of a full school implementation. As the costs and needs have changed the district would like to put interactive whiteboards in all classrooms as opposed to standard displays in the initial allocation. This requires 26 additional interactive displays and subtracts the non interactive displays from the plan.

Additionally, as the plan calls to expand our Chromebook implementation to 1:1, we will require 300 additional chromebooks and 50 teacher laptops to meet this ongoing need.

The subtraction of funds for the Dell VRTX is due to a savings realized in the purchase from the original plan.

As per the original plan -

- 1: Replace Smart Boards throughout the school with new instructional displays. The school is currently using Smart Boards that are 8 (now 12-15) to eleven years old and starting to fail at a high rate. This funding will allow us to provide updated instructional technology for our classrooms which, when paired with new teacher devices will allow wireless projection capabilities for collaborative learning. This requires an increase of 26 Interactive boards and a decrease of 26 Non-Interactive displays.
- 2: Expand Chromebooks implementation to a 1:1 level. We've been fortunate to have a number of Chromebooks already deployed in our district in a cart sharing model. We would like to expand this to afford access to all students. Smart Schools funding will allow us to expand implementation while we replace our existing primary services server which is nearing end of life.
