The district will purchase chromebooks to implement a 1:1 student-to-device ratio with school owned devices for better oversight of the learning environment. The district currently operates in a 1:1 environment however a number of the devices are student owned. Implementation of this plan will not significantly impact current electrical or HVAC needs.
