Much of the internal connection work was able to be funded with e-rate monies allowing for savings in the purchase of switches and other equipment originally planned for purchase with SSBA funds. Reduction to the Network Access line of \$88,073.93 as detailed in entry #10 below. Professional Services cost was lower than expected based on time needed and use of BOCES for some work, savings of \$1,897.82. Total savings of \$89,971.75.
