The approval/implementation of this project will ensure each of our three buildings (K-12) are appropriate outfitted with wireless access points that are appropriately updated and can support the needs of connecting all of our devices simultaneously, particularly during computer-based testing periods. As we are a one-to-one device school, updated WAPs that can handle the volume and bandwith of each building's machines are a necessity. Our current WAP software updates have expired and, as a result, will begin to fail without recourse. Through the pursuit of these funds, we will purchase both the WAPs and the waranties to ensure each installation is protected against failure, and qualifies for at least ten years of free software updates necessary for said devices to continue to operate efficiently.

As mentioned above, the current WAPs are working, but without the ability to continuously update the software, said devices will not work to their capacity, and will have the propensity to fail. Access to these funds will allow us to replace all WAPs K-12, to ensure all buildings have equal, reliable internet access.

The continued use of Interactive Whiteboards fosters kinesthetic student-teacher participation, and ensures equitable acccess to projected materials to all students in the classroom. The projection of District-purchased educational technology software is maximized through the projection, particularly software used to strengthen literacy and numeracy skills (i.e.- IXL). All rooms (both Resouce Rooms and General Education Classrooms) will be fitted with the Interactive Whiteboards, which will ensure all SWD and ELL students have access to learn from these devices. Our full-time Instructional Technology Coach (a teacher on special assignment) has been working with special education/ENL teachers to ensure they are fully aware of Google-friendly applications that assist in the delivery of content for those identified with a disability or for whom which English is not their primary language. Department meeting and professional development day time will be provided to all faculty so that they are fully aware the capacity of these newly-installed devices.

Projection technology allows for students and staff to teach students remotely (for a short or long-term period), and also ensures each of our classrooms can appropriately facilitate Distance Learning as needed, without the limitations of only using a classroom or classrooms designated as Distance Learning rooms.
