The District wishes to invest in the replacement of interactive whiteboards (which are now outdated and not working to capacity) with new projection technology. The District far exceeds the 100 Mbps per 1,000 requirement, as it supports over 200+ Wireless Access Points, with high speed internet coming into the building from both a private vendor (LightSpeed) and a back-up connection via NERIC. The numbers below will verify this efficiency.

As mentioned in previous SmartSchools submissions, all students and staff have fast, reliable access to the Internet via their one-to-one Chromebook devices, which maximize Wireless Access Points (over 200) to gain access to the WiFi/Internet. WiFi is available at all three campuses in all locations of the building, due to the 205 Wireless Access Points installed. Access (via a guest network) is also available in our school parking lots and our main athletic field. 250Mbps is available for all users, minimally.

All electrical needs are currently in place as a result of the current interactive whiteboards in classrooms. Dedicated outlets that power the current SmartBoard infrastructure will be used for the newly installed boards (no additional wiring necessary). Whiteboards will be on carts, which will be assembled from the manufacturer by our own facilities staff (unless the room has the device directly mounted to the wall, which will also be completed by in-house individuals).

The continued use of Interactive Whiteboards fosters kinesthetic student-teacher participation, and ensures equitable access to projected materials to all students in the classroom. The projection of District-purchased educational technology software is maximized through the projection, particularly software used to strengthen literacy and numeracy skills (I.e. - IXL). All rooms (Special Education and General Education) will be fitted with the Interactive Whiteboards, which will ensure all SWD and ELL students have access to learn from these devices. Our full-time Instructional Technology Coach (a teacher on special assignment) has been working with special education/ENL teachers to ensure they are fully aware of Google-friendly applications that assist in the delivery of content for those identified with a disability or for whom which English is not their primary language. Department meeting and professional development day time will be provided to all faculty so that they are fully aware of the capacity of these newly-installed devices.

Projection technology allows for students and staff to teach students remotely (for a short or long-period of time), and also ensures each of our classrooms can appropriately facilitate Distance Learning as needed, without the limitations of only using a classroom or classrooms designated as Distance Learning rooms.
