Shenendehowa Central School has worked very hard to maintain their high-speed broadband and wireless network to support student learning. They regularly work with the local BOCES and the Federal Erate program to maintain reliable and adequate capacity. Since the submission of this application, Shenendehowa has successfully completed the upgrade of their Wireless network. As a result of the use of Federal Erate funds, their Wireless project was completed UNDER budget and estimates, and they have money that wasn't spent. 100% of the wireless access points have been installed.

The cables were re-terminated using district staff so the project was completed and the funds are available.

Shenendehowa is requesting that the remaining funds be released so that they can fulfill other priorities from the Smart School Planning

Components of the VOIP system were completed using Capital Project funds. It was 100% completed and is in use throughout the district today.
