 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

An increase of cameras is needed to complete the district's security system. The cameras will cover the gaps that will assist when viewing areas with limited camera access. Not having cameras in the following exterior areas; (entire length of the bus loop, sides of the buildings, exterior camera facing the roadway); severely inhibits our ability to conduct investigations. Along with doors, additional monitors are needed to provide our safety team with the ability to view our systems. We are currently using laptops to view all 60+ cameras. Our goal is to have all camera images up on monitors to view at all times.

For increased safety and awareness, the district is in need to key fobs for the elevator. Providing key fobs to those in need, allows the district to track who is using the elevator and when. In addition to knowing who has the fobs, we will know the times when the elevator is in use. This will provide responders with important information if the elevators were ever to stop working.

Finally, card readers will be added to the fire doors. At this time, staff do not have the ability to fob into these areas without key access. Updating our fire doors with card readers limits the need to hand out keys to all staff.
