We are looking to purchase new interactive touch panels. Currently we have SMART Boards in most classrooms that are over 10 years old and beginning to fail and have issues that also utilize a seperate ceiling-mounted projector. We are proposing to purchase 78 ViewSonic ViewBoards to replace the existing SMART Boards as well as expand them to all classrooms in the district so that every classroom is equipped with one. The solution will eliminate the need to have a wall-mounted board and the ceiling-mounted projector and combine them into a single LED-Backlit LCD on a mobile cart. The solution will also include a management software, so that they can be remotely updated and managed, a 7-year warranty to support the panels, and a wireless network adapter to connect the panel to our wireless network without needing a physical network connection. All of these features allow the ViewSonic ViewBoard to simply need a single power outlet within a classroom environment to operate, which each classroom has several existing power outlets.

The proposed ViewSonic ViewBoards, interactive touch panels, will enhance differentiated instruction by allowing teachers to provide interactive lessons that target individual needs. The lessons can incorporate many different engagement components such as videos, pictures, interactive activities, websites, and text. These interactive touch panels are located within the classrooms but will allow multimedia, remote video connections, and other methods to bring experiences from outside the school district into the classroom for all students to learn and study such as virtual field trips. Students with disabilities, English language learners, and learning gaps will be addressed by the interactive touch panels by providing technology that provides additional ways to access key content through videos and other visuals for instruction and content. Also the interactive touch panels can be used to increase options for students to demonstrate knowledge and skill through its interactive capabilties. Interactive touch panels also provide learning games and interactive software to supplement instruction.

The proposed interactive touch panels while primarily meant for providing and enhancing instruction in the classroom for students and teachers, can also provide distance and virtual learning opportunities for the students to connect to experiences and programs that are not offered traditionally within the school district or able to be traveled to easily. There are a lot of virtual field trips available that primarily used video and audio to connect to for students and teachers to provide additional ways to access learning instruction and content.

The proposed ViewSonic ViewBoards provide additional capabilities and features that are not present on the current technology. The district currently employs 1.5 technology intergrators that have already been trained on these particular products and will provide training and assistance to all teachers and staff within the district once a teacher receives the new interactive touch panel. The technology department will also assist by the setup and support of the interactive touch panel and associated software and applications that can be used with the panel.
