In 2021 we completed a \$57.8 million capital project that included additions to the high school and Ballard elementary school, updated technology infrastructure, technology equipment, safety and security systems and energy efficiencies that ensure better electrical and other infra structure to support additional technology. The Middle and Senior High Schools have core switches replaced with Smart Bonds School funds. In all 6 educational buildings the fiber optic connection between main date frame and intermediate frame are improved. This ensures power requirements and connectivity support all students with 1:1 devices. Promethean boards aid in instruction for our students using 1:1 devices.

This VIVI Pro Sub 1 Y software allows for wireless interaction between the board and only devices. It is necessary for a more interactive learning experience.

Promethean will replace unreliable, poor quality, outdated interactive devices originally purchased in 2006
