South Jefferson Central Schools believes that students are more successful when they learn in a safe and secure environment. In the first two phases of their Smart Schools program South Jefferson addressed emergency classroom notification and video security. In this application, the district wishes to provide secure managed entrances to their district. The district proposes expanding the number of doors that require identification of entrance and to increase the number of entrances that are monitored. Currently, each building in the district has a few doors that require a programmed key phob when the staff member enters. The district proposes to increase the number of doors at each building. No longer can a misplaced key turn up in unauthorized hands and permit access. The door controls not only control the lock mechanism, but they also synchronize with the video security system that was installed in Phase 2. Now, the user of the phob will also be recorded by the video system for future reference. Also there currently a number of doors that have no monitoring system at all. Though these doors aren't usually used for access, the addition of monitoring units allow the administration to identify unauthorized use of a door or when a door is blocked open for future use. When a door is opened it is identified for the administration and synchronized with the video security system. Unauthorized use is quickly identified and a blocked open door can be responded to.
