**1. Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.**

Spencer Van Etten Central School has been focusing their Smart School projects on improving the safety and security of their buildings. They believe that students who attend school in a safe environment can concentrate on learning and not be distracted by concerns about safety.

In a previous application, Spencer Van Etten proposed to address the challenge of emergency classroom communication in the buildings. When there was an incident, they wanted the students and staff to get the correct information so they could react in a safe manner. The existing classroom communication system was an antiquated analog system that had speakers and spaces added and spliced until it wasn't reliable. That system has been replaced with other funds.

Spencer Van Etten is proposing to submit an amendment to reassign the committed funds to the next priority High Tech Security project proposed.

Spencer Van Etten wishes to replace their existing mechanical classroom and office door locks with a wireless swipe system. With the current system the teacher or administrator has to go into the hall to lock the classroom door from the outside. The new system will rely on a card swipe system. A teacher will swipe the same badge they use to enter the building at their assigned classroom or group of classrooms. The lock will open and they can enter their classroom. In the event of an emergency, one of two things will happen. With the strike of any of the "panic buttons" located in strategic areas of the buildings, ALL doors will lock immediately. If the teacher is aware of an emergency before that "panic button is hit, they can also lock their doors with the push of a button on the inside door handle. Finally, there is a mechanical key for opening the door in the event of a power issue or emergency responders that need to access a room.
