Interactive Whiteboards originally approved \$560,000 - amendment requesting the reduction of \$280,000 for a new total of \$280,000.

Explanation:

The district has originally proposed to purchase interactive display boards for classroom for which we overestimated the cost of the board. As we have completed our interactive board installation, this amendment is requesting the reduction from 140 Interactive Boards originally estimated at \$4000 each at a reduction of \$2,000 each for a total of \$280,000 leaving a balance of \$280,000. This money would be put back into the general allocation.
