Establish a primary Data Center and Network Operations Center (NOC) to eliminate the single point-of-failure that currently exists. This redundant Data Center will provide a second ISP for continued coverage. The Network/Access Costs were original to this SSIP2.2 but will now be funded with an alternative source known as ARPA.

The money was reallocated into contingency and incidental buffer because the Architect's proposal came in substantially lower than anticipated and construction costs continue to rise with construction bids coming in \$1.5 million higher than anticipated for this project. We cannot estimate a dollar amount, but do expect that there will be a considerable amount of change orders needed to complete this project and that is why we moved the money into the contingency and incidental buffer.
