We will install a lockdown system for each of our school buildings. Three buildings total. This will include an incident response panel, lockdown buttons, small speakers, Large IP signage for the gym and cafeterias, Large displays for the hallways, exterior strobes, and zone controllers. First an automatic call will be made to a central station monitoring agency. This will be followed by the station calling 911 and district employees will receive a text message. Exterior blue light strobes will be activated. Digital signage will display a audio and visual message. The zone controller will allow the lockdown system to play an audio message through our existing PA system. In addition this project will also include dual door contacts at all perimeter doors in each of our buildings. The door contacts will provide status for all perimeter doors to know if they are open or closed. The project includes Lockdown systems for all buildings and door status monitoring of exterior doors. The CAT6 cabling being used for this project is to replace existing cabling or following in existing pathways. The Lockdown systems installation for each building is broken out and shown. The installation of the perimeter door monitoring is very labor intensive with wiring to each perimeter door contact causing a higher percentage of installation costs.
