The Waterville Central School District plans to enhance its instructional model by integrating the most up-to-date technology, Viewsonic Interactive Displays and replacing existing Epson BrightLink Projectors that are currently in the teachers' classrooms. These projectors were purchased without utilizing SMART Bonds funds in the past and are currently due for replacement to stay on target with the district's technology replacement schedule. We are removing the Casio XJ-V100 Projectors from the plan to make room for the Viewsonic's that is an all-in-one unit, allowing teachers and all students to interact with it via touch with their finger and they also connect to the other technology currently in the classroom utilized by the teacher. Viewsonics have been approved in previous plans, but the district would like to increase the number we plan to purchase to outfit all classrooms with this technology innovative. We are also removing the Chromebooks, Chromebook Cases, Dell Laptops, and Dell Desktops as the district either utilized COVID funding provided by the Federal Government, or some items are no longer needed due to students utilizing Chromebooks in Classroom Instruction instead of laptops. The district also no longer needs to purchase the 13 LaserJet printers as we move towards utilizing less paper for instruction. These purchases aim to support teachers and all students effectively. The compatibility with existing systems and infrastructure, such as electrical and HVAC, appears to be adequate. Interactive Viewsonics typically require standard electrical outlets for power, and their installation should not strain existing infrastructure significantly. Additional funds are not required for implementation as we will utilize OHM B.O.C.E.S. and/or M.O.R.I.C. services for training staff on how to utilize the technology.
