High-Tech Security Features

This amended project will allow the District to continue upgrading its existing VoIP, IP cameras, access controls, and PA system districtwide. The new IP mass notification system and IP cameras will help assist first responders in cases of emergency.

In this Amendment, The District is focusing on upgrading the existing VoIP, IP cameras, access controls, and PA system. Specifically, we are integrating new IP cameras and communication items into a mass notification system to enhance emergency response capabilities.

Items were removed from the plan primarily due to configuration changes and cost savings. Some components were found to be redundant or less effective in the revised setup, leading to their removal to streamline the system and reduce unnecessary expenses.

Items were added to the plan to address identified gaps and improve overall functionality. The new IP mass notification system and additional IP cameras were included to provide better coverage and more efficient communication during emergencies, ensuring a safer environment for everyone in the district.
