The West Islip School District was allocated \$2,973,629 for SSBA funding. The district submitted a Smart Schools Investment Plan (SSIP) in 2016 for a Phase 1 school connectivity project in the amount of \$1,640,487. This plan was approved by the NYS Department of Education on November 28, 2017. The total costs incurred from the Phase 1 project were \$1,137,770.15. The district received reimbursement for this project on June 14, 2019. The district would like to free up the remaining dollars from Phase 1 (\$502,716.85) and use it for a high-tech security project.

The West Islip School District will utilize the remaining funds available of \$1,835,859 for the installation of a security vestibule in the District Administration Office, which is located at and provides access to the Beach Street Middle School. Security vestibules ensure that all visitors are screened before gaining admittance to a building. They also ensure that no one is able to gain quick access to the building and provide the district with more time to react should someone unauthorized try to enter the building.

This plan is addressing the release of the unspent money from the School Connectivity to be used toward this future high tech security plan.
