The district intends to utilize Smart Schools Bond Act (SSBA) funds to enhance building security by installing high-tech surveillance systems at our elementary school campuses. This initiative includes the installation of 38 exterior security cameras, a dedicated video server, four network switches, and two network bridges to ensure reliable connectivity and comprehensive coverage of all exterior access points. These upgrades are designed to strengthen campus safety, improve monitoring capabilities, and support a secure learning environment for students and staff.

Certain items from the original approved plan have been removed due to a combination of factors. Specifically, some components were funded through alternative sources, and cost efficiencies were realized during the initial phases of implementation. Additionally, the district conducted an updated security assessment, which identified exterior camera coverage as the highest priority for immediate investment. These adjustments allow us to maximize the impact of SSBA funds by focusing on the most critical security needs while remaining aligned with the program's objectives.
