Pupil Transportation Services

The State Education Department has oversight responsibility for school district provision of pupil transportation services to resident pupils attending public and nonpublic schools. Approximately 2.3 million pupils, or ten percent of the nation's pupils, are transported to school each day. One-third of these students are transported on district owned buses, one-third ride contracted buses, and one-third of our students utilize public transportation. The 2020-21 statewide cost of services was approximately \$3.4 billion with state aid of \$2.0 billion in the 2021-22 school year. The Department processes 5,000 contracts and extensions annually for the delivery of services by private contractors to over 480 school districts.



The Department also has jurisdiction over the qualifications for hiring school bus drivers.

The State Education Department has oversight responsibility for school district provision of pupil transportation services to resident pupils attending public and nonpublic schools.

Approximately 2.3 million pupils, or ten percent of the nation's pupils, are transported to school each day. One-third of these students are transported on district owned buses, one-third ride contracted buses, and one-third of our students utilize public transportation. The 2020-21 statewide cost of services was approximately \$3.4 billion with state aid of \$2.0 billion in the 2021-22 school year. The Department processes 5,000 contracts and extensions annually for the delivery of services






